- \$69.30 per ash interment
- \$171.60 per burial

Why an interment services levy? The interment services levy (the levy) is a levy on interment services to fund the cost of Cemeteries and Crematoria NSW (CCNSW; the regulator) to deliver better outcomes for customers and the community, and to support industry to meet the new licensing standards.

When does a service attract the levy? The levy applies at the time the interment service (burial, ash interment or cremation) is rendered, regardless of when it is purchased.

What about services purchased before 1 July 2024? The levy applies at the time the interment service occurs, regardless of when it was purchased. This means that the levy applies to services purchased before 1 July 2024 if the burial, cremation, or ash interment happens on or after 1 July 2024.
